

**NAET Financial Agreement**

I would like to take a moment to welcome you to this clinic and assure you that you will be receiving the very best care available for your condition.

**Payment Arrangements:**

These charges are specific for NAET treatments only. Insurance will NOT cover NAET treatments. Acupuncture and massage are independent treatments and charged separately.

I have developed a package system for NAET. We anticipate that an individual treatment for NAET alone will be 30-45 minutes.

The first visit where we take a health history and evaluate what allergens need to be addressed : \$175 for 90 minutes.

During the treatment for the Basic 17 mixes you may purchase a package of 10 treatments @ \$900.00.

If you pay the total up front, there is discount of \$100.00. Your total is then \$800.00.

You may also pay as you go @ \$90 per treatment. Please understand that it is not guaranteed that you will clear each mix in only one treatment.

The entire Basic 17 may take only 10 treatments or 20-30 treatments or more.

Your body is the guide for what it requires. It can not be predetermined.

After you have cleared the Basic 17 the charge will be \$65 per treatment for 30 min.

If your body allows us to test and/or treat more, than one hour of treatment is \$90.

Treatments can also be added on to acupuncture visits at a reduced cost depending on if it is a Basic or advanced allergen vial.

Credit, debit and checks are accepted to make current payments more convenient for you. A balance will be maintained. You will be apprised of your balance on a weekly or monthly basis (your choice). Additional payments against the balance are welcome at any time but must occur at least monthly. Your balance is considered past due two months after your last treatment. An interest charge of 2% per month may be applied to any past due balance.

If this arrangement becomes inconvenient for you, please discuss this with me so other arrangements can be made.

**Voluntary Termination of Care:**

You may choose to discontinue care, as originally discussed in your first treatment, at any time. Should you choose to suspend or terminate your care and treatment, any outstanding fees for professional services and products are immediately due and payable. For this payment we accept only credit, debit or cash, no checks. If there is a balance in your favor, you will receive that balance back.

If you terminate NAET treatments before completing the Basic 17, you may find a return of some of your symptoms over time.

If you stop clearing on any substance before it has been rechecked after treatment and reinforced it may also come back.

I hope this answers any questions you might have regarding your financial arrangements.
